




**Republic of Texas (RoT) Championship & AAFTA Grand Prix**

**Rifle FT Match:** 120 shots (60 on Saturday, and 60 on Sunday) – **All AAFTA classes + Unlimited**

**Pistol FT Match:** 60 shots (Friday afternoon) – **All AAFTA classes**

**Entry Fee:** \$95 per shooter including lunch on Saturday and Sunday. \$105 after March 25. No refunds after April 10. Friday Pistol match entry is FREE with paid Rifle match entry.

**Rules:**

- AAFTA safety and shooting rules apply. For more information, please refer to the AAFTA Handbook: [AAFTA Handbook -- Official AAFTA Rules \(Last Updated December 2023\)](#)
- Eye Protection is always required. Safe gun handling will be always enforced.
- Rangefinders are not allowed on the competition course at any time, except Unlimited Class.
- Guns will be chronographed before each shooting day begins.
- Match Director reserves the right to combine classes with low entries.
- Protests/disputes must be immediately taken to the Match Director, whose decision will be final.
- For concession requests based on medical/health conditions, please contact the Match Director at least 1 week prior to the event.

- 2nd Place (at least 5 shooters)
- 3rd Place (7 or more shooters)

1. Start out going **South** on US Highway 287 toward E Broad St.  
Then 0.12 miles
2. Take the 1st **right** onto E Broad St.  
Then 3.08 miles 3.20 total miles
3. Turn **left** onto Lillian Rd.

*Lillian Rd is just past Retta Rd*

- Then 0.28 miles 3.48 total miles
4. Lillian Rd becomes County Road 525.  
Then 0.99 miles 4.48 total miles

5. 11500 COUNTY ROAD 525. Red Gate on Left  
*Your destination is just past Village Ln*  
*If you reach Lost Creek Rd you've gone a little too far*
